We have few months people go out

From the President

We have seen far too many mass murders in the last few months, weeks, and days. The one in San Bernardino, CA is especially disturbing as we had two people who thought it was more important for them to go out and kill several people than to raise their six month old daughter. These individuals are not representative of the Muslim religion. They have been radicalized to the point that they seem to be

mentally ill. Let's remind ourselves that this is not the teaching of the Muslim religion but of radical extremists.

However, there is good news. As reported in the December issue of the Educator, Congress is finally going to adopt a new version of the Elementary and Secondary Education Act. This has been a long time in the making. While not perfect, this appears to be a substantial improvement as a replacement for No Child Left Behind.

In addition, our state budget has a surplus of up to two billion dollars. The Legislature has an opportunity to address funding issues that have been delayed. A good start is to fund pre-school education, reduce tuition at our two and four year public colleges, and repair and build bridges and roads.

Education Minnesota Retired will have our political conference on February 18th at the Sheet Metals Workers' Union in Maplewood. In addition, precinct caucus night is March 1, 2016. If you are available, I hope you will attend in order to support issues regarding education, pension, Social Security, and Medicare. We are also planning to have lobby days during the Legislative session as well so make sure we have your email address so we can communicate with you if necessary. I hope to see you in February or March.

RECAP 2015 Retired Fall Conference



The 2015 Education Minnesota Retired Fall Conference was held September 14-16 at Chase on the Lake in Walker, MN. The conference opened on Monday evening with a Welcome by VP Julie Jagusch (President Larry Koenck was absent due to illness). The 45+ attendees introduced themselves and elaborated on personal activities since retirement. Author Bill Schrankler provided the evening's entertainment with a power point presentation detailing his most recent book "Shadows of Time......Minnesota's Surviving (Train) Depots." Tuesday morning opened with the Legislative Update by Jodee Buhr. The final Omnibus Bill was all about licensing and funding with policy changes in: Licensure, Testing and Full Service Community Schools. The new legislative session may not start until March 2016. Topics will include: Supplemental

Budget Bill, Testing, and Teacher Recruitment and Retention. YOU CAN make a difference! Meet with legislators, attend lobby days, contact: lobbyteam@edmn.org if you are interested. TRA Executive Director, Laurie Fiori Hacking, provided an update on the health of TRA and of our pensions. The goal is to get us on

track for 100% funding in 30 years. Options being considered are:

- 1) Extending the amortization period
- 2) 1 year COLA freeze
- 3) 1% employer contribution increase

The morning ended with a session on "Finances/Wills/Trusts" by Kent Schutte and Jamison Tessneer.

Afternoon sessions included "Emotional Wellness" and "Exercise and Active Aging." The day concluded with dinner and wonderful entertainment provided by the "Geritol Frolics"- a musical group from Brainerd.

Wednesday's sessions included an "Insight Into Warren Buffet-Finding Missing Money" by Joe/John



Gindele (yes, brothers/twins) and a "State of the Union" update by Education Minnesota Treasurer, Rodney Rowe. Currently there are several (18) cases before the Federal Supreme Court dealing with the collection of agency fee. The earliest decision will probably be spring 2016. We have been given the gift of time to prepare for a possible loss in Education Minnesota Union membership. One needs only to look at Wisconsin. Before Scott Walker there were 110,000 members and currently 42,000 members. The implications are staggering. We need to work in sync to promote "the value of belonging." The conference concluded with an ESI Member Benefits presentation by Christine Thornborrow and a drawing for door prizes.

Investment Assumption Rate of TRA By Marti Zins

As reported in an earlier article, TRA's experience study, released at the beginning of this fiscal year, contains an actuarial recommendation for a funding change to maintain pension fund sustainability. The course correction needed represents 4% to 5% of the total fund. Generation of that change is the current discussion among the board and stakeholders.

The TRA board is recommending to

the legislature an assumed rate of 8%, down from the current rate. Other sustainability measures are being identified, costed, discussed and communicated to and with stakeholder groups and policymakers for feedback. Various combinations of options are being reviewed. Based upon our reviews, discussions and actuary information, the board is developing a legislative package for 2016 that is in keeping with TRA funding guiding principles.

Those principles are:

- 1. <u>Shared sacrifice</u> The responsibility for addressing TRA's financial challenges should be shared among all TRA stakeholders including active members, benefit recipients, contributing employers and the state.
- 2. <u>Intergenerational equity</u> Financial sustainability measures should avoid creating or exacerbating imbalances among generations of TRA members and retirees in terms of the benefits they receive and contributions they make over their working careers.
- 3. <u>Long-term financial sustainability</u> The goal of the financial sustainability package is to maintain TRA's financial stability in the short term and attain full funding within a reasonable period of time over the long term. Assuring the fund's long-term stability is critical to maintaining the valuable defined benefit protection for Minnesota's public educators. Both contribution levels and benefit levels need to be sufficient, affordable and attainable by members.
- 4. <u>Maintain recruitment/retention value of pension benefits</u> Studies show that employees, particularly teachers, value defined benefit pensions and that those pensions significantly improve teacher recruitment and retention. The retention of experienced teachers benefits students and creates a high quality education system that helps the state's economy. Any changes that lower pensions should not undermine the recruitment and retention value of TRA's defined benefit plan, particularly as the nation and state face teacher shortages.

The TRA board hopes to have some firm recommendations for the legislature in place after the December 16th meeting. We continue to seek your thought and input as we work to draft policy that sustains TRA pensions now and in the future. We all benefit when we can agree on pension policy moving forward that we, as stakeholders, can support.
