Appendix One - TRA Board Report for Education Minnesota Retired - May 20, 2013Martha Lee (Marti) Zins

- 1. Meeting of TRA Board was May 15, 2103.
- 2. Meeting dates were set for the year.
- 3. Topics for the board retreat on August 14 were given. This is when the board looks at greater depth into topics such as GASB, updates from actuary on financial information, demographics of the state, teacher supply and demand, TRA staffing and the board does its annual review and sets goals.
- 4. The budget for fiscal year ending June 30, 2014, was adopted at \$1,585,943,000 for expense and \$580,800,000 for revenue meaning \$40 m more revenue with contribution rates up and more annuity payments. A key cash flow statistic is that fund expenditures are about 2.7 times the fund's annual contributions. 99.1 % of total expenses are payments. Reminder ELSA accounts earn no interest (351 accounts remain.) TRA projects staffing from 82.5 employees to 90.5 positions. We are working on disaster recovery plans.
- 5. GASB implementation rules are to be published Jan 2014. These affect all employer units.
- 6. IRS has sent letter that we are a qualified plan for tax purposes.
- 7. Successor plans are in place for continuing staffing as folks retire and new are trained in. This is a major issue for the board as is the replacement of Technology folk who we train and then go to find higher paying jobs. The state agreed that we could pay more to attract staffing. We will need for staffing to finish our .Net computer transition to our upgraded technology system
- 8. Elections results, Mary Supple and Rob Gardner and Marti Zins won another 4 year term. Thanks for your support.
- 1. We have a new system of investment whereby our daily cash is invested rather than accumulate for a month. More revenue generation. 86 cents of every pension dollar paid to TRA pensioners comes from investment earnings and member contributions. We paid about \$23 m for SBI investment of our resources.
- 2. Legislative issues pending but administrative bill, omnibus bill I and II are expected to be signed by the governor. St. Paul and Duluth will get \$13 for 2 years and then no money. A study to consolidate with TRA is planned with reporting in January. TRA position is come in fully funded but what that means is up for grabs.

3. July 2012 began at \$16.74b May 14, 2013 had \$18.44 b an increase of 16.5%. Inflation is 1.45%. January 1, 2014 a 2% increase will occur for pensioners.
