FROM THE PRESIDENT



With 2013 behind us, we look forward to a new year. With that comes new issues for us to be concerned about. The economy seems to be turning around and hopefully will continue to do so.

Most of you will have already received notification of your pension increase of 2%. It may not seem like much, but this does have a huge impact on the econo-

my of Minnesota, as 49,941 TRA Retirees received \$1,350,453,742 in pensions in 2013 (Comprehensive Annual Financial Report FY 2013). This report is available at www.minnesotatra.org.

The Legislature will be getting pressure from certain groups that believe public pensions are costing taxpayers huge amounts of dollars. Every dollar paid to public retirees in Minnesota comes from three sources: approximately **69 cents comes from investment earnings, 17 cents comes from employers, and 14 cents from employees** (*Retirement Systems of Minnesota - Myth vs. Fact October* 2013). I believe these outside groups will continue their push to change the public pension systems. The major push is to change the defined benefit system to a defined contribution or hybrid system. Education Minnesota Retired is on record to retain the defined benefit system.

We are also on record of support for the mergers of Duluth and St. Paul retirement systems, provided they come into TRA with full funding. A report will be given to legislature on the study conducted by TRA regarding merger discussions.

2014 is an election year, the Governor and other State Officers, along with the House of Representatives, are all up for election. If we want to keep our supportive legislature and Governor in office, we will all need to stay involved in the political process. Attending precinct caucuses on Tuesday, February 4, 2014, is crucial.

VOLUNTEERING IS REWARDING

I started volunteering for the American Red Cross a few years before I retired. I became a member of the Disaster Assistance Team. The primary duties involve meeting with families immediately after a fire had damaged or destroyed their home. We provide assistance to make sure they have a place to stay, clothes to wear, and food. This often occurs even as smoke still rises from the embers and the firefighters are still pouring water to douse the last of the threats.

It is rewarding on so many levels to be the one who can make the worst of days a little better and provide the first steps to recovery.

I became interested in other types of local responses which included working in shelters when large apartment building fires displaced large numbers of folks. I worked in a shelter for victims of the North Minneapolis tornado.

Upon retiring, I was able to deploy for longer assignments. In the first six months I was sent to Duluth for flooding, Tampa for a hurricane, and New Jersey for Super-storm Sandy. It was in New Jersey, where as an EMT, I was assigned to provide health care in a shelter for over two hundred people. I saw up close how every individual is only a single incident from being homeless and needing to rely on the kindness of others for even the most basic of needs. No amount of planning, money, or insurance could protect these wonderful people from having nowhere else to go.

I continue to volunteer locally and will deploy nationally as can be practical. Red Cross provides all the training and puts volunteers in a group of terrific like minded people. After just a few, two to four hour classes, volunteers can be doing disaster relief, client casework, health care, mental health, logistics, or many other duties that make a difference in the community. As a retirement gig it allows me to pursue the interests that led me to teaching in the first place, but to do so in a completely new and ever so rewarding setting.

POLL BOOKS FOR MINNESOTA BY MYRNA DORAN

The Minnesota Legislature has been discussing updates to the way voting takes place in the state. One of the possible methods of updating our voting process is to utilize electronic poll books.

St. Anthony, along with five other cities, participated in a pilot project utilizing poll books during the 2013 General Election. This technology was developed only for the check-in and registration process of voting. The actual marking of ballots and counting of ballots remains the same. Several companies provided their products for this trial. Some other states are already using this technology.

As an election judge in St. Anthony, I had the opportunity to be trained on the process of using a poll book as well as actually using them during the election. Our poll books had all the information of current registered voters loaded into the computer poll book. Attached to the computer were a card swipe unit, a bar code wand, a signature pad and a small printer.

The process of checking names and

addresses of registers voters was a simple and fast one. Once located, voters just signed their name on the signature pad (like retail stores have) and a receipt was printed with their information. This receipt was then taken to receive a ballot. The rest of the process was the same as before.

The process for registering new voters using the card swipe unit was rapid if voters had a MN driver's license or a MN photo ID. If they were not available, election judges typed the information into the computer. The information was then printed out for the new voter to sign.

Our City Clerk indicated there would be a great time savings at the county level in the processing and updating of all the data regarding voters.

The Legislature will be discussing this idea during the next legislative session. It will be interesting to watch this process and the discussions around this topic. As an election judge, I think it would speed up the process of voting and provide greater accuracy in data entered into the voter registration system.

We were working the Retired booth at the Fall Conference last year, something we had done since the birth of Education Minnesota.
