


## Action

## **Two Woman Warriors**

AFT President Randi Weingarten, Education Minnesota President Denise Specht, NEA Past President Lily Eskelsen-Garcia

AFT President Randi Weingarten and former NEA President Lily Eskelsen-Garcia are women leaders who have made history. Weingarten is the first openly gay individual to be elected president of the 1.7 million members of the American Federation of Teachers. Eskelsen-Garcia was the first Latina to be elected president of the National Education Association. NEA is a membership of 3 million and counting.

Eskelsen-Garcia began as a school lunch lady eventually becoming an elementary school teacher. In 1989, she was named Utah Teacher of the Year. She expanded her union involvement and become state president of the Utah Education Association. Eskelsen-Garcia continued her union activism at the national level and was elected NEA Secretary/Treasurer, NEA Vice-President, and finally NEA

President. She held each position for the maximum 2 terms. She personally took on the fight to repeal "No Child Left Behind" and succeeded! In 2016, she took on the newly appointed Secretary of Education-Betsy DeVos. On Aug. 31, 2020, Eskelsen-Garcia retired from NEA as an active member and joined NEA Retired. Just like many of us in retirement, she will continue to fight for quality public education.

Weingarten was born in New York City. Her early interest in trade unions and political advocacy was formed when her mother's public school union went on a seven week strike in 1974. Weingarten attended law school and handled high-level union grievances against the State of New York regarding school funding and school safety. She worked for 3 years as a lawyer for the firm of Stroock & Stroock & Lavin, as well as teaching law, political science, and U.S. Government at Clara Barton High School in Brooklyn. She, too, expanded her union involvement to become United Federation of Teachers president in 1997. In 2008, Weingarten became the president of the AFT, a position that she currently holds. Weingarten advocates a grassroots approach to education reform and says that public school officials should welcome the views and account for the needs of educators when working to help schools better serve their students.

Both Eskelsen-Garcia and Weingarten have worked hand in hand with labor leaders both nationally and locally. There is power within these two women; there is power within the people they represent. These two women are warriors, all in the name of public education.

## **PERA Update**

One of the components of the significant 2018 statewide pension law changes was a movement by PERA to tie annual postretirement benefit increases to a Consumer Price Index (CPI). The goal is to more closely connect increases to actual inflation during both lower and higher inflationary periods. This helps ensure more equitability from one generation to another. Past attempts to tie increases to investment returns, funding status, or use fixed rates have resulted in measurable intergenerational inequities across the PERA plans.

Annual postretirement increases for PERA's General members are now tied to the same CPI as used by the Social Security Administration (SSA) to determine the annual Social Security benefits increase. General retirees receive 50% of the

Social Security increase, but not less than 1.0% or greater than 1.5%. Since the law change, the COLA has been 1.4% in 2019 and the 1.0% in 2020. The 2021 COLA is yet to be determined, but the 1.0% minimum is likely to be applicable again.

Postretirement increases vary for each statewide pension plan. Due in part to different plans using different approaches, the 2018 pension legislation included a requirement for the Legislative Commission on Pensions and Retirement (LCPR) to complete a postretirement increase study by the end of 2020. The study is required to take into account the purpose of postretirement adjustments and whether governing statutes are consistent with that purpose. The study is also required to consider alternative methodologies for determining postretirement adjustments and to evaluate the inflation based methodology currently used by PERA.

PERA's postretirement increases are intended to both provide inflation protection and to improve intergenerational equity. The use of a CPI serves as a way to both measure inflation protection and to compare benefits across generations. Ideally, if all members always received an increase equal to 100% of CPI each year, both goals would be met.

Undoubtedly there will be some stakeholders desiring better inflation protection now in the form of a higher CPI percentage in the PERA formula or a higher cap (or both). This type of increase would require either contribution increases or jeopardizing the health of the plan. Increasing benefits does not seem to be the intent of the LCPR study.

While increasing inflation protection now may not be imminent due to cost concerns, there is still possibility to take another step towards the second goal of trying to improve intergenerational equity. A possible next step for the PERA plan is to consider widening the current narrow range between the minimum and maximum benefit increases. This change would not significantly change the expected long term benefits or costs of the plan, but it would be a step closer to the goal of retirees receiving consistent inflation protection across generations when measured against CPI. The PERA component of the LCPR study will likely focus on its second goal of improving comparability of benefits across generations rather than trying to increase the current CPI percentage or maximum benefit.

# NEA Retired Annual Meeting and NEA Representative Assembly

The 37th NEA Retired Annual Meeting was held virtually on June 29-30. Virtually means that each and every one of the attendees could attend in their own homes, offices, etc. I was able to attend in my rumpled house clothes and no one was the wiser! President Sarah Borgman called the meeting to order; the Pledge of Allegiance and the National Anthem were done by NEA President Lily Eskelsen Garcia. Garcia sang and played her guitar then spoke briefly. She spoke about how retirees are powerful and strong. Garcia also reminded us that as of Sept. 1, she will be one of us. NEA-R membership keeps growing, at last count we are 321,985 strong!

The virtual Retired Annual Meeting met for two hours each day. Due to the limited agenda, there were no new business items. However, there was discussion and debate on one proposed amendment to the NEA-R bylaws, article VII, section 2. A proposed new subsection that allows the NEA-R President to temporarily serve as the duly elected alternate for NEA-R members of the NEA Board of Directors in the event that no alternate is available.

NEA-R President Borgman delivered her address. She spoke about the upcoming election and challenged us to make ability, creativity, responsibility, activity, possibility and opportunity work for us. The remainder of day one was used to present awards. Our own Education Minnesota Retired won first place for largest percentage of membership gain with 1.052%. We were also added to the Membership Hall of Fame. Any award winner that has earned a membership award three times in the same category becomes a member of the Hall of Fame. A member of the Hall of Fame is not eligible to win in the same category for three years. Congratulation Education Minnesota Retired! The second day of our virtual meeting concluded with candidate speeches. Voting for candidates and the bylaw proposal will be done by secret mail-in ballot this year.

Retired delegates also attended the 158th Annual Meeting and the 98th NEA Representative Assembly virtually on July 2-3. In her keynote address, President Lily Eskelsen Garcia reminded us to speak up, to speak out and to speak for the National Association so that it can continue to do its work. There were over 7,200 delegates who listened to messages from former First Lady Michelle Obama and from former Vice President Joe Biden. Each thanked the delegates for demonstrating to their students the determination that it takes to create a better future for themselves and for their communities.

Delegates also heard from Teacher of the Year Tabatha Rosproy, Higher Educator of the Year Elizabeth Davenport, ESP of the Year Andrea Beeman, and NEA Executive Director Kim Anderson. Anderson is the first woman and person of color to be executive director. Candidate speeches were also given. This year, voting for candidates will be done by secret mail-in ballot along with voting to approve the NEA 2020-2022 Strategic Plan and Budget and presidential endorsement.

The 2021 Representative Assembly will be held on July 2-6 in Denver, Colorado. On behalf of Victoria Ellis, Charles Hellie, Julie Jagusch, Diane Larson, Walt Munsterman, Judy Rohde, Jayne Schwalbach, Wes Tessman, and myself, we sincerely thank you for giving us the opportunity to represent our state and our retired organization. We represented you with pride, purpose and professionalism!

## **TRA Update**

The TRA board has been active this summer and met for all functions remotely. Here is a summary of issues we dealt with this summer.

- June board meeting J. Michael Stoffel was rehired as Executive Director, Marti Zins was reelected board chair, Luke Olson was elected vice-chair and Joel Stencel was appointed chair of the audit committee with Denise Anderson vicechair. A budget for fiscal year July 1, 2020 – June 30, 2021 was adopted. An application process for replacement board member Marshall Thompson, who resigned to seek other employment, was authorized.
- August special meeting The TRA Board reviewed six applicants for the open board position and after a thorough discussion of candidates, Noel Raph, special education teacher in the Osseo Area Schools, was selected as the replacement. He will serve through June 30, 2021, at which time he can decide to run for election to a new term.
- August information meeting The Board reviewed the actuary information, received an update from Mansco Perry, Executive Director of the State Board of Investments (SBI), reviewed TRA Board fiduciary responsibilities, looked at TRA funding information and gathered information that will form the basis of any future Board actions and decisions.
- TRA Board members participated virtually in the annual summer trustee workshop taught at
  University of California Berkeley Center for Executive Education Haas School of Business. There
  were thoughtful discussions about guiding pension funds through turbulent waters. A wide range
  of topics were discussed including investments, staffing, working from home, fraud issues,
  restructuring the work place and federal legislation. All of the TRA board member participated.

We were saddened to learn that effective Sept. 1, MMB Commissioner Myron Frans, a wonderful pension advocate, stepped down as Commissioner to become the University of Minnesota's senior vice president of finance and operations. He will be missed and we thank him for all his work on behalf of the state, educators and schools in Minnesota as well as his work with the finances of Minnesota. His replacement is Jim Schowalter who worked under both Governors Dayton and Pawlenty.

Thankfully, nothing concerning TRA has come to play at any of the state special legislative sessions to date, although we continue following activities. Additionally, we have finally received a salary range for our TRA Deputy Director and will be working to get that position posted and hired. Staff continue to work from home and all pension payments continue to be paid in a timely way. For the foreseeable future TRA staff and the Board will continue to operate remotely. The annual audit of TRA has been progressing with a final report to be issued soon. TRA retiree numbers are being processed at about the same pace as the past few years, while more inquires about disability are being made.

I would urge you to go to MyTRA.org to for pension updates and access your account. Be well and safe.

## **Education Minnesota Unity Summit**

Several Education Minnesota Retired members attended the Education Minnesota Unity Summit back in January, before everything changed.

75 percent of the funding that is available to our local school districts comes from the state. While there is a little funding from the federal government, the inequality of local tax bases leads to inequality of the other 25 percent. Districts vary greatly in the amount of "excess" levies they are able to pass in referendums, some even have zero "excess" levies.

The focus of the conference was to develop the

knowledge and skills to work with members and community members to elect Minnesota legislators who will support fully funding public education and then advocate with those legislators to find ways to provide that equitable funding for public schools.

With the pandemic, the inadequacies of school funding and equity issues are even more evident than they were at the time of the conference in January.

## Open retired seat on the TRA Board

The TRA Board of Trustees is seeking candidates to fill one retired-member seat on the board. The term of retired teacher Martha Lee Zins expires June 30, 2021. The new four-year term for this position begins July 1, 2021. There are no term limits on board positions.

Trustees meet about six times a year to oversee the administration of the pension fund. Board members act as TRA fiduciaries in accordance with Minnesota law and are subject to state economic interest disclosures.

To request an application, call TRA at 651-296-2409 or 800-657-3669 or download one at www.MinnesotaTRA.org. The application must be received at TRA's office by 4:30 p.m. on Fri., Dec. 18. Eligible members will receive ballots and candidate biographies in early spring. Only retired members are eligible to vote for retired-member board positions.

Election results will be certified by the Board of Trustees in June 2021 and published on MinnesotaTRA.org.
