## Who will choose the next governor of Minnesota?

Minnesota Gov. Mark Dayton will complete his second and final term at the end of 2018. Every voter in Minnesota has a role to play in choosing the next governor and the sooner you engage, the more of a voice you will have in that selection process.

Some members have told me they are not into politics. However, as beneficiaries of public pensions and as citizens who care about kids in public schools, politics is into us. For example, the governor vetoed a bill in 2016 that would have reduced Teacher Retirement Association (TRA) Cost of Living Adjustments (COLAs) without an employer contribution increase. Gov. Dayton said that was unfair to place the burden on retired and future retiree TRA members without any sacrifice from employers (school districts and the state). We need a governor who understands our pension benefits were earned and are deferred compensation.

Politics will determine the future stability of public pensions and the quality of public education. Your voice is needed in the 2018 election process. The Nov 6 election will determine who is in the governor's office, as well as who is in the Minnesota House of Representatives. Your votes are critical. In addition, you can help choose candidates by attending precinct caucuses Feb. 6 and by working to encourage all members to vote. Did you know that in the last governor's election, 33,000 Education Minnesota members did not vote?

Education Minnesota Retired will host a political conference, March 7, to help members learn about the election, how to get involved, and about the 2018 legislative session. Retired Educators Association of Minnesota (REAM) members are also invited to attend.

## PERA Board of Trustees votes on legislative proposals for 2018 legislative session

The PERA Board of Trustees unanimously approved legislative proposals for the General and Police & Fire Plans during their Dec. 14 meeting. The board also reaffirmed their position from last year to change the investment return assumption from 8 percent to 7.5 percent for future valuations.

#### **General Plan**

The legislative proposal adopted by the board includes replacing the current cost-of-living adjustment (COLA) trigger structure with one tied more closely to inflation, or the Consumer Price Index (CPI). The current 1 percent COLA is not projected to trigger to 2.5 percent until 2045. To keep the change cost neutral, the annual benefit increase is proposed to equal 50 percent of CPI, with a floor of 1 percent and a cap of 1.5 percent on the actual increase payable. This would ensure annual increases no less than the current 1 percent and provide the possibility for an increase up to 1.5 percent if warranted by actual inflation rates.

The legislative proposal also includes:

- Extending the amortization period to 2047.
- Eliminating the 1 percent post-retirement increase prior to the full retirement age.
- Eliminating augmentation in the early retirement factors.
- Eliminating augmentation for deferred members.
- Reducing the interest rate on refunded contributions from 4 to 3 percent.

Under the proposal the plan's funding status will improve more rapidly, increasing the likelihood of long-term plan sustainability. The proposal does not require an increase in employee or employer contributions and will mean a more equitable post-retirement increase structure that is tied to actual inflation.

PERA staff presented letters from stakeholders supporting the package. PERA staff has met with various stakeholder groups since last summer to receive input on the legislative proposals.

## **TRA Board Update**

The TRA Board met on December 13. During the meeting, Cavanaugh Macdonald Consulting reported on the fiscal year 2017 actuarial valuation report, GASB 67/68 reports and results of economic assumption experience study. Part of their conclusion was to recommend reducing the assumption rate to 7.5 percent beginning July 1. However, even though the TRA board approved the changes, they shall take effect only if legislation is enacted lowering the investment return assumption to 7.5 percent. There was also consensus among board members that if there were any additional pension changes they would need to follow the

TRA Board Guiding Principles that were adopted on Sept. 21 and are as follows:

**Shared commitment** – The responsibility for addressing TRA's financial challenges should be shared among all TRA stakeholders, including active members, benefit recipients, contributing employers and the state.

**Intergenerational equity** – Recommended financial measures should avoid creating or exacerbating imbalances among generations of TRA members and retirees in terms of the benefits they receive and contributions they make over their working careers.

Long-term financial goals – The financial goals of the recommendations are to maintain TRA's financial stability in the short term and make progress toward full funding within a reasonable period of time over the long term. Attaining these goals will require ongoing monitoring of TRA's financial status and periodic adjustments in plan provisions as financial conditions change. The fund's long-term stability is critical to maintaining the valuable defined benefit protection for Minnesota's public educators. Both contributions levels and benefit levels need to be sufficient, affordable and attainable by members.

Maintain recruitment/retention value of pension benefits – Studies show that employees, particularly teachers, value defined benefit pensions and that those pensions significantly improve teacher recruitment and retention. The retention of experienced teachers benefits students and creates a high quality education system that helps the state's economy. Any changes that lower pensions should not undermine the recruitment and retention value of TRA's defined benefit plan, particularly as the nation and state face teacher shortages.

There is a correction to the article, 2017 Legislative Action: New Minnesota Teacher Licensing Process and Board (page 10), which was in the fall issue of the retired newsletter, Action. Please see the correction below. We apologize for any confusion.

One of the biggest changes affecting retired educators is short-term and long-term substitute licenses. Retired Minnesota teachers (effective July 1, 2018) will be able to get a lifetime short- or long-call substitute license without having to renew their license or complete continuing education requirements as long as they previously held a Minnesota teaching license and are collecting a pension from TRA or SPTRFA. Retirees previously had to complete continuing education and other renewal requirements in order to maintain licenses that allowed them to work for more than 15 consecutive days for the same teacher. A lifetime long-call substitute license will allow them to teach for longer periods, including for one or more consecutive school years, provided they are replacing a teacher who is absent. Any teacher who meets requirements for a long-call substitute license will qualify for a Tier 3 or 4 license, but they will need to apply for that license unless they hold a valid five year license as of July 1, 2018.
