We have been informed that Sen. Pappas and Rep. O'Driscoll intend to offer a very limited, one-year pension sustainability measure in the form of an amendment to the pension bill. This amendment will be taken up, beginning Monday morning, by various committees (see hearing list below). This scaled-down stop gap measure is being offered because there appears to be a lack of funding for the state and school district employer contribution increases proposed under the original sustainability bills. The amendment's authors wish to preserve some of the savings from the original sustainability bills.

The key provisions of the stop gap proposal include:

- 1. Reduces the COLA for MSRS Plans (other than State Patrol and Judges) and TRA for <u>one year only</u>, effective January 1, 2017, by 0.25% for MSRS and by 1% for TRA, resulting in a calendar year 2017 COLA adjustment of 1.75% for MSRS and 1% for TRA.
- 2. Removes the COLA trigger for MSRS-General, MSRS-Correctional, TRA, and SPTRFA so there will be no automatic increase in the COLA for each of these plans if specific funding thresholds are reached; and
- 3. Provides for an increase in the employer contribution of 0.5% of salary, for both the basic and coordinated plans of St. Paul Teachers Retirement Fund Association, effective July 1, 2018 (funded by the St. Paul School District).
