## REPORT ON THE NOV. 23 PAC BOARD MEETING

The Nov. 23, 2019, meeting of the Education Minnesota Political Action Committee focused on the upcoming elections with full funding of public schools set as the PAC's priority. In that vein, the PAC will work in 2020 to win a pro-public education majority in the state Senate and maintain the current pro-public majority in the Minnesota House. These priorities were set by the PAC board at its Sept. 21 meeting.

Endorsements and contributions will be decided strategically based on issues. Early endorsements will be made only when a candidate has demonstrated support from their district's educators through submission of a petition signed by 50 constituent educators for House districts and 100 for Senate districts.

The board is planning to maintain and build on the site-based initiative for 2020. The PAC has adopted four core strategies: build 4,400 worksite unity team leaders by Sept. 21, 2020, who are organic leaders in their buildings; take a build-test-build approach to achieving 100 percent voter turnout among members, especially strategic groups, on Nov. 3; organize parents and community members around a powerful message to unite and persuade support of public schools; and create issue-first legislative endorsement process for full-funding and race-class narrative trainings.

Kaye Peters, Education Minnesota Retired's member on the PAC board, will reach out to retired members to have these conversations. Since the role for retired members is new this year, the mechanism for growing participation, in lieu of a concrete worksite, is being developed.



#### Fall Breakfast

The annual Fall Breakfast was held at the Science Museum on Oct. 17, 2019. The guest speaker was Phia Vue, who spoke about identity theft targeting seniors. Also attending were officers and staff from Education Minnesota including Rodney Rowe, secretary-treasurer, Bernie Burnham vice-president and Jodie Buhr, lobbyist.



## TRA UPDATE

Oftentimes when we talk about pensions, the numbers are what people remember. The following are some statistics which might be of interest to you.

- TRA distributes about 150 million to eligible annuitants which help support local communities and economies
- The pension fund earned 7.3% last fiscal year
- If you break down the pension dollar, 70 cents of the dollar is

from investment earnings, 16 cents is from the employers and 14 cents is from the employees

- There are 82,965 active members, 51,436 inactive members and 67,285 benefit recipients as of June 30, 2019
- The average retirement age is 63.1 years old with 22.6 years of service
- The average regular monthly benefit is \$2,190.81
- For the current retirement year, approximately 74% are female and 26% are male
- The vast majority of members retired in June with 48.7% and the least in February with 2.1%
- TRA's oldest annuitant is 114 years old and there are 119 annuitants age 100 or older
- The annuitant receiving benefits the longest has received them since July 1, 1967
- The projected average number of years a member retiring in 2019 will receive benefits is 28 years with a projected average lifetime benefit of \$772,800 (assuming a \$2,200 monthly benefit with no annual increase)
- There are 590 employer units participating in TRA
- The largest participating employers are Minneapolis Public Schools (4,325), Anoka-Hennepin ISD #11 (3,399) and Minnesota State (2,870)
- The pension benefit formula multiplier (currently 1.9% per year) × years of service × high-5 average salary × early retirement reduction factor (if any) = annual lifetime benefit with no refund
- The TRA funded ratio (actuarial value) as of July 1, 2019 is 76.8%

## PERA

Monthly benefit payments to retired members of the PERA General Employees Retirement Plan will increase by **1%** in January. PERA Police & Fire Plan retiree benefit payments will also increase by **1%** while PERA Correctional Plan retirees will receive a **1.6%** increase.

Annual retiree postretirement increases for PERA's General and Correctional members are tied to the same Consumer Price Index used by the Social Security Administration (SSA) to determine the

annual Social Security benefits increase. The SSA recently announced that the January 2020 Social Security benefits increase will be 1.6%. General retirees receive 50% of the Social Security increase, but not less than 1.0% or greater than 1.5%. The 1.0% minimum will apply in 2020.

PERA moved to tie annual increases to a Consumer Price Index as part of the 2018 legislative package. The goal is to more closely connect increases to actual inflation during both lower and higher inflationary periods. This can help ensure more equitability from one generation to another. Past attempts to tie increases to investment returns, funding status, or use fixed rates have resulted in measurable intergenerational inequities for the PERA plans. The use of minimums, maximums and varying percentages were all a result of what each plan was considered able to afford.

Expected future annual retiree benefit payment adjustments vary for each statewide pension plan. While the PERA General Plan increases will vary annually, the Teachers Retirement Association increases are currently on a set schedule to be 1% for several more years until they start to increase by 0.1% each year until reaching 1.5% annually. Due in part to different plans using different approaches, the Legislature commissioned a COLA study to be completed by the end of 2020. The study is required to take into account the purpose of postretirement adjustments and whether governing statutes are consistent with that purpose. The study is also required to consider alternative methodologies for determining post-retirement adjustments and to evaluate the inflation based methodology currently used by PERA. Whether the study will result in any changes is difficult to determine. However, anyone who closely monitors their annual increase may want to pay attention to how that study progresses.
