2015 RETIRED ANNUAL MEETING BY BOBBIE MARGO

This year's 32nd NEA Retired Annual Meeting was held at the Hyatt Regency in Orlando, Florida from June 28-29, 2015. The theme for this meeting was "Unite, Inspire, Lead." Marilyn Warner, President of the Florida Education Association-Retired extended greetings. She reminded us that years ago Ponce de Leon was searching in Florida for the "fountain of youth." Warner stated that in looking around the room, "the fountain of youth is alive and well!"

The first keynote speakers consisted of a panel of the three top NEA officers; President Lily Eskelsen Garcia, Vice-President Becky Pringle and Treasurer Princess Moss. They indicated that retirees are the fastest growing segment of NEA with 306,177 members up 6,138 from 2014 (YIPEE)! NRLB-No Retiree should be Left Behind-we ALL are important to the health of NEA. As retirees, we have walked the walk and talked the talk. We are ready and we are able to work side-by-side with the active educators in our locals. We must elect policy makers who are pro-education. Retirees have the expertise and the wisdom to make this happen. We, as retirees, are an extension of the NEA family.

On the final day of the retired meeting, business was conducted. Two \$2,000 scholarships from the Jack Kinnamon (Cat in the Hat man) Fund were presented.

Ten new business items were discussed/voted upon. To date, NEA retirees have raised \$35,000+ for the NEA Fund for Children and Public Education.

Mary Kusler, Director NEA Government Relations, was the day's final speaker. Kusler spoke about how 1965 was an incredible year! The ESEA (Elementary/Secondary Education Act), head start and Medicare were all born. We NEED 2015 to be the new 1965! Congress's attention needs to focus on the re-authorization of ESEA. A child's zip code should not determine his/her educa-

tion. For the 2016 elections, the House will continue to be Republican because of redistricting but the Senate make-up will be a much better year for the Democrats. PLUS it is a Presidential election year!



I completed my 6th and final year (termed out) representing the NEA Retired on the NEA Resolutions Committee. However, Judy Rohde was one of six elected to represent the NEA Retired on the NEA Resolutions Committee for the 2016 term (way to go Judy)! ED MN-Retired will continue to be represented at the national level.

The NEA Retired Meeting adjourned on Monday, June 29th. All of the Education Minnesota retirees packed up our "stuff" and switched hotels to join our Education Minnesota State Delegation in order to attend the NEA Representative Assembly. Our hotel was the Caribe Royal. We were located about 7-8 miles from the Convention Center so it was back to depending on shuttle buses for transportation.

2015 NEA REPRESENTATIVE ASSEMBLY BY BOBBIE MARGO

The NEA RA was held at the Orlando Orange County Convention Center from July 3-6, 2015. The first day of business opened with greetings from Andy Ford, President of the Florida Education Association. Ford stated that even though the air outside was hot, humid, icky, and sticky (it was pretty nasty), to put us in a better frame of mind, we needed to use the word "sultry." Minnesota's own Chelsey Jo Herrig, Chair of the NEA Student Program, led the delegates in the Pledge of Allegiance.



Special guest speaker was Randi Weingarten, President of the AFT. Weingarten reminded us that women who have made history were NOT well behaved! Her speech closed with the sobering thought that now, for too many families, the American Dream is out of reach. NEA President Lily Eskelsen Garcia followed with her speech regarding the need to give our educators the time, the trust, and the tools to do their job.

Speeches from "Teacher of the Year" Shanna Peeples (English-Texas) and "Education Support Professional of the Year" Janet Eberhardt (California) were well received. Peeples stressed the need for less testing and more teaching-with research and data supporting this statement. Research and data are like a bikini-a lot is left uncovered, but the important parts ARE covered! Eberhardt stated that the cooperation of

ALL moving parts makes for a successful school.

This year's "Friend of Education Award" went to Paula A. Kerger, President and CEO of the Public Broadcasting Service (PBS). PBS is America's largest on-air classroom. Can you say Sesame Street? Throughout the years, the characters from that program have permeated our culture. Where would we be without Kermit?

We DID have time for business. Delegates elected (by secret ballot) were Shelly Moore (Wisconsin) to the NEA Executive Committee along with 4 at-large ESP individuals to the NEA Board of Directors. Again by secret ballot, 2 Constitutional Amendments and 4 By-Law Amendments were voted upon. Discussion "on the floor" for 4 days involved 122 new business items, 3 policy statement amendments, 14 legislative amendments and a number of standing rules and resolutions. Delegates spent even more this year with regard to how much it will actually **COST** to implement new business items.

The 2014 Rep Assembly spent \$821,797. The 2015 Rep Assembly spent \$1,000,000+.

NEA by the numbers:

- 2. There were over 7,000 registered delegates from all 50 states
- 3. NEA is the largest union in America-over 3 million members
- 4. Business concluded at 7:29 pm on Monday, July 6
- 5. The 2016 RA will be held in Washington, DC

EYE ON THE PENSION

BEYOND THE EXPERIENCE STUDY: TRA CHALLENGE FOR NEW FISCAL YEAR

The TRA board will be reviewing the information gleaned from the experience study just completed by the TRA actuary. Actuaries make reasoned assumptions about the cost of the pension plan and what contributions and investment returns are needed to fund that plan. The experience study, mandated by Minnesota law every four years, reviews those assumptions to see how the assumed results compare to what actually transpired. TRA requested that the legislature not change the assumption rate until the experience study was completed and the findings could be reviewed. After the study is reviewed, the TRA board will create a plan with adjustments to keep the pension on target for full funding. These plans are reviewed by stakeholders and go to the legislature for implementation.

Some of the assumptions actuaries make include:

- What is the ratio of males to females?
- What is the life expectancy of males and females?
 Has it changed and how?
- How long are educator careers?What age do they retire?
- Are educators earning what we assumed for salaries? Has it changed and how?

If assumptions change, several questions need to be answered:

- Is the fund required to pay out more money or are we not meeting the expectations of the current actuary tables?
- Do we need new actuary tables?
- Are the investment assumptions sustainable given the investment market?

The State Board of Investment, SBI, also studies their operations to see if they are investing in the best balance of assets, working with money managers who are performing well, and have an investment assumption rate that is sustainable and reasonable (currently "Select and Ultimate" for TRA and 8% for PERA and MSRS). TRA, its actuary and the SBI look to long-term rates and typically have a horizon of 50 years. However, legislators frequently look more short term, approximately two years, and may propose actions that respond to short term information rather than the long term outlook.

Pension components are interrelated. If you lower the investment rate, the fund must either increase the amount active teachers and employers contribute or re-

duce or freeze the COLA paid to retirees. Any action taken has an effect on another part of the plan; therefore thoughtful consideration must be given to any change.

The TRA board is unique in that it owes an equal fiduciary responsibility to the pension plan member, the state and the taxpayer. The board must balance the interests of all three equally when making a decision.

The TRA board will review the data at their August meeting and chart a course of action for the future. Maintaining the stability and viability of our defined benefit pension fund is our top priority. How to accomplish this will require thoughtful discussion and action. Sharing information among stakeholders is vital; for all stakeholders share in the success and the solution for a stable pension plan.

EDUCATION INTERNATIONAL WORLD CONGRESS

The Education International 7th World Congress was held in Ottawa, Ontario Canada in the Shaw Centre from July 21-26, 2015. Ottawa has a population of over 1.2 million and is on the banks of the Ottawa, Rideau and Gatineau Rivers. The city is the Capitol of Canada and is the home of The Government of Canada, The Parliament, The Senate and The Supreme Court. Ottawa is also rich in culture and heritage with its many national museums, parklands, waterways, and historic architecture.

Education International (EI) was founded in 1993 in Stockholm, Sweden as an association of national teachers' unions and a merger of their international umbrella organizations. IFTU (International Federation of Teachers' Unions-AFT was a member) and WCOTP (World Confederation of Teaching Professions-NEA was a member) joined to form a more powerful organization. E.I.'s World Congress is the supreme governing body of Education International and is held every four years in different world locations. E.I. has 5 regions including: Africa, Asia/Pacific, Europe, Latin America, North America/Caribbean. Previous E.I. Congress locations have included Zimbabwe, Washington D.C., Thailand, Brazil, Germany, and South Africa. Education International is a federation of 396 associations and unions in 171 countries and territories. E.I. represents over 32.5 million educators and support professionals in education from Pre-K through higher education institutions.

At this 7th Congress, NEA was represented by 50 official delegates and 65 registered observers. There were six Education Minnesota Retired members who attended (and paid for) this year's Congress-Myrna Doran, Julie Jagusch, Sharon Kjellberg, Bobbie Margo, Carmen Peters, and Judy Rohde. This year's 7th Congress brought together 1000+ delegates from education unions in 154 countries.

The Congress program included general sessions, caucuses, breakout sessions, social events, and receptions. The Congress dealt with 45 resolutions, 95 amendments, 7 policy paper resolutions, and the emergency resolution dealing with the Nepal Earthquake Recovery. The official languages of the Congress were English, French, Spanish and German. However, translation equipment was also provided since many participants did not speak or understand any of the official languages. An awards dinner/ceremony was also held. This year's recipient of the "Albert Shanker Education Award" was Luisa Bautista-Yu (from the Philippines). The "Mary Hatwood Futrell Human and Trade Union Rights Award" was presented to Ahmed Jassim Salih Al-Shiblawi (from Iraq). Elections were held for several Executive Board positions. NEA President Lily Eskelsen Garcia was elected as E.I.'s Vice-President for North America/Caribbean. AFT President Randi Weingarten was also elected to a board position representing the North America-Caribbean region.

On behalf of my 5 Education Minnesota Retired colleagues, I encourage you to get your passport papers in order and to check out E.I.'s website www.ei-ie.org. When you attend an E.I. Congress you experience the true meaning of unionism and solidarity world-wide! The next four years will be here before you know it!


