Grow Locally

Politicians are known to proclaim that "all politics are local." This axiom could be taken to mean that people tend to be more active and committed with issues that directly affect them. Most of us would not disagree. Education Minnesota Retired supports many issues that retirees are concerned about including senior health, Social Security, Medicare, pensions, identity security, child welfare and of course, education. We also support addressing these issue locally.

Education Minnesota Retired is anxious to charter and affiliate with retired local chapters throughout the state. There are already a number of such organizations but, as with so many things, the pandemic curtailed our growth. Here are some reminders for how Education Minnesota charters locals and how we can help.

To form a retired local, interested Education Minnesota Retired members will need to:

- Form a committee of five or more members.
- Write and approve a local Constitution and Bylaws.
- Agree to implement the policies of Education Minnesota Retired.
- Prepare to receive all the benefits and privileges of membership in Education Minnesota Retired.
- Fill out a request to affiliate with Education Minnesota Retired.

How can we help? We offer:

- Grants up to \$500 to assist in costs of organizing.
- Provide samples and assistance in writing Constitution and Bylaws.
- Connect you with leaders of other locals in Education Minnesota Retired for networking.

Once formed, an affiliated local chapter of Education Minnesota Retired can pursue many worthwhile goals. My local chapter, Burnsville Area Retired Teachers (BART), has four missions in starting our group. We wanted to: keep retirees socially connected to each other by arranging social events wrapped around information presentations, organize around Education Minnesota Retired endorsed candidates and legislation for political action, organize service projects that benefit our local schools and community and stay apprised of the activities, people and events happening in our former schools and districts.

We are anxious to help you form a local. Grants and assistance are waiting. Creating and participating in a group can be a very effective and rewarding. Plus, you will have many more opportunities to have an impact locally! After all - all politics (and many good organizations) are local.

NEA Board of Directors

The first in-person NEA Board of Directors meeting in two years was March 12-14 in Washington D.C. The first day was scheduled for lobbying our senators and representatives. Topics for lobbying included educator shortage, inclusivity and antibullying.

One agenda item was the proposed NEA Policy Statement on Safe, Just, and Equitable Schools which will be presented to the 2022 NEA RA for final adoption. If adopted, this new policy statement will replace the existing policy statement on discipline and school-to-prison pipeline.

The guiding principles are:

- Adopting a restorative justice philosophy to create a thriving school climate.
- Relevant professional development for culturally competent educators.
- Eliminating disparities in disciplinary and behavioral practices.
- Eliminating the criminalization and policing of students in schools.
- Student, family, organizational and community engagement.

The NEA Board also had a lot of discussion on the two-year strategic plan and budget for 2022-24. Once adopted by the Board, it will be presented to the NEA RA for final approval. NEA dues will increase \$2 for active teachers and \$1 for active ESP members.

The NEA Foundation 2022 Salute to Excellence in Education Gala was held on May 13. A Minnesota educator is one of the five educators who will be receiving a \$10,000 award. One of our retired members, Lynette Wayne, received this award as an active teacher.

The NEA RA will be held July 3-6, in Chicago at the McCormack Place. It will be a hybrid event with the NEA protocol for COVID-19 in effect for those attending in-person. Vaccination, wearing masks, social distancing and frequent testing will be required. There will be a RA in-person attendance limit of 6,000.

Retired members work for greater inclusion and equity

A new committee was recently established to focus on racial equity and diversity. The purpose of the Racial Equity and Diversity (READ) committee is "To inform and lead the Education Minnesota Retired Board to continually increase its commitment to inclusion, diversity, and social justice. We will advance this understanding and commitment with members." The committee is led by co-chairs Joan Beaver and Chuck Lyons and there are now 14 members on the committee.

As a first step toward understanding our own perspectives on racial and social justice, many Retired Board Members participated in the four segments of Cultural Competency training by Education Minnesota staff. We had the first two segments on Jan. 4 and the last two on March 21. We felt it was most effective to do the training face-to-face, even though it meant delaying the second meeting due to the COVID-19 surge. However, the free training for members is available on MEA Online. CEU credits for relicensure are available. The committee continues to explore identity issues, barriers to inclusion by diverse members, and how Retired can work within our organization for social justice. We will examine the structure of Education Minnesota Retired as outlined in our Constitution and Bylaws to remove barriers for people of color and individuals from other marginalized groups. We plan to look for ways to support the Education Minnesota Action Items related to racial equity and social justice which were approved at the Representative Assembly. This committee will work to develop a relationship with the Education Minnesota Ethnic Minority Affairs committee as well.

- Assistance in living independently



PERA Update

Prior to the start of each legislative session, PERA's Board develops an agenda of legislative initiatives. Typically these are based on stakeholder input and intended to travel through the Legislative Commission on Pensions and Retirement (LCPR). PERA's 2022 legislative initiatives were limited, focusing on the investment return assumption. The initiative was to seek a lower investment return assumption to reflect our actuary's opinion that a 7.5 percent investment return assumption is no longer reasonable.

PERA Executive Director Two factors had a significant impact on the 2022 legislative session. Rising inflation rates have driven some stakeholders to seek post-retirement benefit

increases and a state surplus has given hope that funding may be available to provide those increases. Given the timing of both these events, it was not uncommon for stakeholders to advocate directly with the legislators on legislation.

As the end of the session nears, there are two significantly different proposals impacting PERA. In the House, HF4306 would provide two separate lump sum payments to retirees. The first payment would be in either late January or early February 2023 and would be equal to 2.5 percent of the sum of an individual's prior calendar year annuity payments. A second payment in 2024 would be based on calendar 2023 annuity payments (excluding the 2023 lump sum). The bill included funding sufficient to cover all benefit payments. In the Senate, SF3541 provides significant benefit increases for Police & Fire members, but entirely excludes PERA General members.

The pension proposals related to PERA are extremely different and it is hard to say what the final result may be. While the versions differ vastly on which groups benefit and to what degree, they both include a proposed change to lower the investment return assumption from 7.5 percent to 7.0 percent. On that component at least, PERA's initial goal will be met. However, the path to get there was far from what we would have originally thought possible.


Foundation
